## WHILE IN CLUB HAL



### AGE GROUPS

Each program features age specific events. Children may participate only in the program designed for their chronological age.

### SIGN IN/OUT

Kids aged 3-6 and tweens aged 7-12 must be signed in and out of Club HAL by an authorized adult who is at least 18 years of age and whose name is indicated on the child's consent form. A password will be selected by the parent/guardian of the child. The password will need to be disclosed to the youth staff upon collection of the child.

Club HAL does not offer meal services. Children must be picked up from Club HAL between sessions.

### FACE MASKS

For the safety and health of our younger guests, we recommend face masks be worn while participating in Club HAL activities.

### CHILDREN WITH SPECIAL NEEDS

Special needs children requiring one-on-one care must have a parent present. Adults are not permitted to remain in the facilities unless attending to a child with special needs.

### ILLNESS

Temperature checks are required to enter Club HAL. A child will not be admitted if they show symptoms of fever, vomiting, diarrhea, unexplained skin rash, discharge from nose or eyes, irritability, continuous crying or if they show indications of contagious conditions such as head lice and scabies. Children with infectious diseases may not be allowed back into the youth center without permission of the ship's medical staff. All medical costs are the responsibility of the parents/guardians.

### MEDICATION

Staff are not permitted to store or administer any medication for participants. Parents/guardians must collect their child from Club HAL to provide any required medications.

### BATHROOM ISSUES

Children must be completely toilet trained. No diapers or pull-ups are permitted in Club HAL. Staff cannot provide restroom assistance.

### BEHAVIOR

Inappropriate behavior is not permitted. Continued disruption will result in parent notification and dismissal from Club HAL.





## WHILE ON BOARD

### SAFETY WRISTBANDS

All children ages 12 and under are required to wear their Lifeboat Assembly Station wristband at all times throughout the cruise. Wristbands are available at Guest Services and at Club HAL.



### ALCOHOLIC BEVERAGES

Guests must be 21 years of age to purchase alcohol, unless otherwise specified.

### CASINO

Guests must be 18 years of age to enter the casino.

### SWIMMING POOLS

Guests must be 18 to use the SeaView Pool. Children are welcome at the Lido pool under the glass dome. Children under 16 must be accompanied and/or supervised by their parents at all times while in or around the ship's pools and hot tubs. There is no lifeguard on duty at any time.

### GYM & JACUZZI

Guests must be 16 years of age to use the gym, hot tubs or steam rooms.

### MAINSTAGE SHOWS

Guests must be 18 years of age to sit in the first two rows. Children must be accompanied by a parent/guardian.

### PARENT/GUARDIAN RESPONSIBILITIES

Parents/guardians accept supervisory responsibility for their children who are not participating in the Club HAL program. Parents/ guardians are asked to restrain their children from engaging in any loud or disruptive behavior, running in the public rooms, open decks and pool areas or playing in elevators.

## OUR STAFF

Our hosts will treat all youth fairly and with respect, regardless of race, sex, age or religion. While interacting with our young guests, Club HAL staff will not use physical or verbal punishment, give preferential treatment, engage in inappropriate physical contact (like full-frontal hugs, lap sitting, tickling, kisses, and wrestling), use off-color language or jokes, share their personal contact information with guests, take photos of or with Club HAL guests, or fraternize with minors outside of the Club HAL program.
